

# Director's Report September 2012

## **Symphony**

The upgrade to Symphony 3.4.1 is scheduled for the weekend of October 28, 2012. Workstations will not be able to connect to Workflows if the client has not been updated. We will be sending you much more information on the upgrade including release notes and client upgrade instructions closer to the upgrade date — for now we just wanted to give everyone a heads up so that you may plan accordingly.

## **SmartPay**

The SmartPay service is still being field tested by Edison, Monroe and Piscataway. The reports prepared by Comprise do not yet do what we need to assist us in allocating the money collected but I think we are very close. Once that issue is resolved we can open it up to everyone.

At the time the service is made available across the consortium we will add links to SmartPay on the iBistro page as well as within My Account in iBistro. We will also be sending out a press release announcing the service.

### **Boopsie**

LMxPRESS was submitted to the various app stores and is now available in the Android and Blackberry stores. We are awaiting availability in the Apple store before a press release is sent out. You can download the app now at Imxac.boopsie.com.
